## 1 Scope of Services

Runway Career Connect provides mentorship, career counseling, and experiential learning via national events (Kathmandu), the Nepal Tour (regional cities), and pre-events including **Sangam**, **Lex Arena**, and the **Pre-SEE Olympiad**.

## 2 User Eligibility

- **Students (Aged 16–22):** Our primary audience is youth at the +2 level or equivalent.
- **Minors:** Users under 18 should access this platform with the consent of a parent or legal guardian.
- **Accuracy:** You agree to provide truthful information during registration for workshops, expos, or counseling sessions.

## 3 Intellectual Property

All content, including event names (**Sangam**, **Lex Arena**), logos, and the “**Runway**” brand, are the intellectual property of Runway Career Connect.

- **Personal Info:** Name, age, interested course, contact details, course affordability, college of interest, +2 examination card, and academic history.
- **Engagement Data:** Which pre-events (like Lex Arena) you attend and your career interests.
- **Media:** Photos or videos taken during our 168+ school visits and national events for promotional use (with implicit consent through event attendance).

- To match you with relevant mentors and career pathways.
- To send updates regarding the Nepal Tour and the main Kathmandu event.
- To share anonymized statistics (e.g., "Over 22,000 students engaged") with our educational partners and stakeholders.

### 3 Data Sharing

We do not sell your data. We only share relevant details with:

- **Partner Institutions:** Colleges or scholarship providers you explicitly express interest in.
- **Government Authorities:** Only if required by the laws of Nepal.
